The Regional Blood Centre in Peshawar, with its exemplary community engagement programmes, research output, and international recognition by ISBT and WHO, serves as a model for the rest of the country. The Peshawar RBC's transition to annual reports and quarterly newsletters reflects our commitment to timely communication and transparency in our operations.
